No charges or modifications of this agreement shall be valid unless in writing and signed by client and Appliance Service Center. This agreement is subject to termination at any time by Appliance Service Center and shall not relieve the person to whom services were rendered of responsibility for the cost of the services.

This agreement will be constructed in accordance with the laws of the State of Oregon and will become effective when approved by an authorized Appliance Service Center employee.
